Members will be required to have a functional presence in the UK, either an office or a permanent sales representative, that provides a good standard of customer service and the opportunity for complaints, redress, recall, return and/or replacement of goods. Please tick the box to confirm this.

Consolidating importers and freight agents

This category of membership is subject to a 1% levy on invoiced sales of imported livestock, added to the sales invoice. Levy payments should continue to be paid monthly.

This category will also be subject to an additional banded payment which will apply from 1 January 2023. To enable to invoice you promptly please advise which band you fall into according to the following table. Please note that your band is based on your UK turnover of the aquatics, element of your business only.

Wholesaling importers

This category of membership is subject to a 1.1% levy on the import value of livestock. This is subject to an annual cap of £13,200 [but will be subject to the annual inflationary increases applied to all OATA members]. Levy payments should be paid monthly at the above rate, but once the cap is reached no further payments will be required for the calendar year.

Both categories are subject to a minimum threshold payment of £1,000 per year

DATA Protection, The General Protection Regulation (GDPR).

As a trade association with members, we need to process your information as a legitimate interest as provided by you as part of the membership application. This will be kept on the membership database in the office to enable us to contact you with information, on an ongoing basis. Once a year a membership list will be produced and sent to all current members of the association as part of the AGM. You will also be registered the Department for Business Energy and Industrial Strategy for inclusion in the Primary Authority Register to be able to receive Assured Advice. If you wish you can opt out of this in writing a letter or sending an email to the OATA Office. You will be asked to sign and return a form agreeing the Code of Conduct and agreement to the GDPR, before you will become a member.
